### **General Tournament Information**

**Start Time:** 8:30 am for 4-team pools, 8:00 am for 5-team pool - Doors will open at 7:00 am at MHS. 1st round officiating team should be there by 8:00 am for 4-team pools, 7:30 am for 5-team pools. **Warm-up 3-3-1 (shared serving)**

**Officiating:** Coach must be up or down official for all matches.

**Pool Play Matches:** 4-team pools, 3 sets to 21 for the first 4 matches, with no cap. The last 2 matches you'll play 2 sets to 21, with no cap.

**Playoff Matches:** Two-out-of-three sets. First two sets to 25 with no cap, third set (if needed) to 15 with no cap.

**Placing:** Placing will be determined by sets won/lost, head-to-head, point differential (+/-), flip of a coin.

**Seeding:** Following pool play, teams will be seeded into tournament playoffs. All teams will advance to a tournament.

- The top eight teams advance to the Black Division playoffs.
- The 9th thru 16th seeded teams will advance to the Orange Division playoffs.
- The 17th thru 21st seeded teams will advance to the White Division.

Awards given to the 1st and 2nd place teams in the Black Division, the 1st place and 2nd place teams in the Orange Division and the 1st place teams in the White Division.

**Warm-up Balls:** Please bring your own warm-up balls. Game balls will be provided. **No pepper or ball-handling in the hallways please.**

**Team Camps:** Please encourage players to keep camps, team benches, and scoring tables clean.

**Concession Stand:** A concession stand will be available. **NO COOLERS** in the building please.

**Location:** Marshall High School is located on the NE side of the intersection of Minnesota Highways 19 and 23.
